

## Competition

### **1. Organizer of the competition: MAU MAU s.r.o. (“the organizer”)**

### **2. Competition date:**

The competition will take place in the Czech Republic between the 10th of May and the 30th of June 2008.

### **3. Participation in the competition:**

The competition entrant must be over 18 years of age and a permanent resident of the Czech Republic.

Entrants may submit their answers by properly filling in the competition coupon:

- a) via the website [www.praguefoodfestival.com](http://www.praguefoodfestival.com) during the competition, or
- b) via the website [www.grand-restaurant.cz](http://www.grand-restaurant.cz) at the 2008 Prague Food Festival on Žofín Island, 20-22 June 2008.

In both cases, the entrant must show a validated one-day ticket for the 2008 Prague Food Festival.

Failure to comply with the competition terms will lead to exclusion from the competition. If an entrant wins the competition without complying with the competition terms, e.g., by giving false information, he or she shall not receive the prize.

### **4. Competition winner and prize:**

Whoever gives the first, most accurate answer to the competition question shall win the prize – a meal to the value of CZK 3,000.

6. If none of the entrants answer correctly, the prize shall go to the person who gives the most accurate answer.

8. The prize will be sent to the winner at the address given in the competition coupon within a month of the end of the competition.

9. The competition organizer reserves the right at any time to alter the competition terms or to cancel the competition without giving reasons and without liability or compensation.

10. The competition organizer shall not bear responsibility for technical failures of the websites
